MAYOR SPANO: Good morning.
Roll call.
MS. LYRAS: Good morning.
Mayor Spano?
MAYOR SPANO: Here.
MS. LYRAS: Peter Kischak?
MR. KISCHAK: Here.
MS. LYRAS: Wilson Kimball?
MS. KIMBALL: Here.
MS. LYRAS: Melissa Nacerino is
excused, and we still have Lucille on
the phone.
MAYOR SPANO: Okay, Cecile. We
have at the desk the minutes from the
October 29th, 2019 meeting.
Are there any questions?
Hearing no questions. Does
anybody want to make a motion?
MS. KIMBALL: Motion.
MAYOR SPANO: Wilson has made a
motion that we accept the meeting
minutes, seconded by Pete.
All in favor?
(A chorus of ayes.)

2 MAYOR SPANO: Any negatives?

3 The item is passed.

4 Number three, Mary, financials
5 for December 2019 and January 2020.

6 MS. LYRAS: Thank you. For the
7 months of October through January the
8 corporation received approximately
9 622,000 in fees closing on 222 Lake,
10 CSEE, and Dayspring.

11 Our cash on hand as of January
12 31st is 3.4 million. And we have our
13 accountant on hand if anyone has any
14 questions.

15 MAYOR SPANO: We have our
16 accountant on hand. Are there any
17 questions?

18 Pete has made a motion,
19 seconded by Wilson.

20 All in favor?

21 (A chorus of ayes.)

22 MAYOR SPANO: Any negatives?

23 The item is passed.

24 Let's go to number four,
25 resolutions for consideration.

2 MS. MCGILL: The first
3 resolution is an authorization for
4 disbursements of funds for a security
5 system.

6 Michael Curti representing the
7 resolution.

8 MR CURTI: Thank you, members
9 of the board.

10 This authorization is for
11 disbursement of funds for a security
12 system for the IDA offices here at
13 470 Nepperhan.

14 Insofar as the arrangement
15 here, for the agency space and also
16 the YEDC space, there is a lease
17 between the city and the landlord of
18 this building, and then the
19 corporation and also the agency are
20 sublessees of the city.

21 The city is going to be making
22 certain improvements to the security
23 system here at 470, and the
24 corporation is going to make payments
25 to the city for those improvements.

2 To the extent that there are
3 improvements that do not benefit the
4 agency but perhaps benefit other city
5 agencies, there's going to be a
6 reconciliation of whatever rent we
7 pay to make sure we're only paying
8 for things that benefit our space.

9 This would be an amendment to
10 our distinct sublease agreement to
11 basically pay back the city as
12 additional rent whatever improvements
13 that are made.

14 MAYOR SPANO: Are there any
15 questions?

16 Hearing no questions.

17 Wilson has made motion.

18 Seconded by Pete.

19 All in favor?

20 (A chorus of ayes.)

21 MAYOR SPANO: Any negatives?

22 The resolution is passed.

23 MS. MCGILL: Next item is a
24 resolution to authorize entering into
25 an agreement with City of Yonkers

2 funding surveys related to potential
3 projects. The related projects here
4 are Grant Park at 345 McLean Avenue.

5 Mike Curti?

6 MR CURTI: Yes. This
7 resolution is to enter into agreement
8 with the city to provide certain
9 funding for surveys for potential
10 projects that will involve the
11 corporation at some point in time,
12 whether it's providing sales tax
13 relief or also mortgage recording tax
14 relief.

15 The nexus is to lessen the
16 burdens of government, which is one
17 of the powers of the corporation.
18 And of course there will be a
19 provision in this funding agreement
20 to the extent that the corporation is
21 not involved in the project, we will
22 be reimbursed whatever funds that we
23 lay out.

24 MAYOR SPANO: Any other
25 questions?

2 Pete's made motion, seconded by
3 Wilson.

4 All in favor?

5 (A chorus of ayes.)

6 MAYOR SPANO: Any negatives?

7 The item is passed.

8 Resolution three.

9 MS. MCGILL: Resolution to
10 authorize entering into an agreement
11 with City of Yonkers for the funding
12 surveys of the Cacace Garage.

13 Mike Curti?

14 MR CURTI: This resolution is,
15 again, to also enter into an
16 agreement with the City of Yonkers to
17 provide certain funding in
18 furtherance of a potential project
19 involving the corporation. That
20 project would be the construction of
21 a new Cacace garage.

22 There have been some
23 discussions with the city to utilize
24 the city as issuer of bonds in order
25 to fund the project.

2 And so in order to pursue that
3 project with the city, we would enter
4 into an agreement whereby we would
5 pay for the borings and the other
6 surveys to determine the feasibility
7 of the project.

8 And if the project weren't to
9 go forward with the corporation's
10 involvement, we would seek
11 reimbursement of any funds that we
12 outlaid.

13 MAYOR SPANO: Any questions?

14 Wilson made motion, seconded by
15 Pete.

16 All in favor?

17 (A chorus of ayes.)

18 MAYOR SPANO: Any negatives?

19 Hearing none.

20 The item is passed.
