WHEREAS, the Corporation desires to appoint Larry Sykes to the position of General Counsel of the Corporation; and

NOW, THEREFORE, BE IT RESOLVED BY THE MEMBERS OF THE YONKERS ECONOMIC DEVELOPMENT CORPORATION AS FOLLOWS:

- <u>Section 1.</u> The Corporation hereby appoints Larry Sykes to the position of General Counsel of the Corporation, whose responsibilities shall be as established by the Board of Directors from time to time.
- <u>Section 2</u>. The Corporation is hereby authorized to do all things necessary or appropriate for the accomplishment of the purposes of this resolution, and all acts heretofore taken by the Corporation with respect to such activities are hereby approved, ratified and confirmed.
  - Section 3. This resolution shall take effect immediately.
