The primary objectives of the local government's investment activities are, in priority order:

- a. To conform with all applicable federal, state and other legal requirements (legal);
- b. To adequately safeguard principal (safety);
- c. To provide sufficient liquidity to meet all operating requirements (liquidity); and
- d. To obtain a reasonable rate of return (yield)

(III) Results of Annual Independent Audit

The firm of PKF O'Connor Davies, LLP has been engaged to perform an audit of the 2023 financial activity. The work was completed in March 2024. The firm issued an unmodified opinion.

(IV) Investment Income Record

In December 2023, the YEDC received \$95,885.08 from an interest bearing MMA account with Flagstar Bank.
